# 1. GENERAL CONTRACTING CLAUSES

Unless otherwise stipulated in writing, placing an order with NIRBUNJATIS EXPERIENCE SL will imply acceptance by the USER of these legal conditions. No stipulation made by the USER may differ from those of NIRBUNJATIS EXPERIENCE SL if it has not been expressly accepted in advance and in writing by NIRBUNJATIS EXPERIENCE SL.

### 2. RESERVATION AND PAYMENT PROCESS

Our automatic availability and price calculation system will allow you to choose the room you are interested in and immediately make the online payment of 100% of the rental price.

Booking confirmation: Once 100% payment has been made, the booking will be confirmed instantly and you will immediately receive an email with all the details (contact person details, dates etc.)

Online payment security: NIRBUNJATIS EXPERIENCE SL is committed to protecting USER data to the maximum extent possible.

### Inputs and outputs

The entrances and exits of our accommodations are:

Tickets: From 3:00 p.m. to 8:00 p.m. (CAMINO DE VALDECARRETAS, PLOT 364 - HORMIGOS 45919 (TOLEDO)).

Before 3:00 pm your accommodation will not be available. If you arrive earlier, please call us so we can leave your luggage.

For arrivals after 20:00, please contact the property directly. The property does not have a 24-hour reception and cannot guarantee check-in after 22:00.

Upon arrival at our establishment and in accordance with current legislation, you must give us the reservation form or show us confirmation of it or simply identify yourself with a valid identity document and we will proceed to check the occupants of said reservation.

We authorize your credit card upon check-in to ensure that there are sufficient funds to pay your final bill -- any extra charges, additional services contracted but not paid for, or any incidents during the use of the facilities and amenities we make available to you -- and we keep this amount throughout your stay. The amount we verify will be  $\in$ 100 per night.

The accommodation is left clean. Bath towels and sheets per person are included in the rental price.

Departures: Check-out time must be before 12:00 am. Before leaving, you must go to reception to communicate your departure and to confirm that everything is in order.

### **Client Responsibilities**

The client agrees to respect the Community regulations. During the hours of rest from 10:00 p.m. to 9:00 a.m., it is not



permitted to use the rooms for party celebrations or to make noise. Under no circumstances is it permitted to occupy the accommodation by more people than those established in its maximum capacity.

The use of electricity and water must be rational.

Smoking is not permitted inside the rooms. Pets are not allowed. Children under 10 years old are not allowed.

Rooms not adapted for disabled people

The pool is open from 10:00 to 19:00. It is forbidden to nail objects such as parasols, awnings, etc., or to use inflatable mattresses inside the pool.

Minors under 16 years of age must always be accompanied by their parents and under their responsibility.

The person holding the contract is responsible for the correct behaviour of all its occupants; otherwise, NIRBUNJATIS EXPERIENCE SL reserves the right to expel the occupants of the accommodation, without the right to future claims or any type of compensation.

Neither NIRBUNJATIS EXPERIENCE SL nor the owner will be responsible for any direct or indirect damage that may be caused as a result of misuse of the accommodation, including but not limited to: damage, loss due to fire, theft, crime, accidents or other types of damage.

# 3. CANCELLATIONS (RIGHT OF WITHDRAWAL)

- The modification and refund policy is subject to the contracted rate.

Gift Boxes:

The amount of the gift box must be paid in full.

The gift box is valid for one year from the date of purchase, and can be chosen on any day except February 13, 14 and December 24, 31 in the "All Year" option.

The "Sunday to Thursday" gift boxes do not include the days mentioned above, as well as public holidays and eves.

Returns of items purchased within any gift box are not accepted.

If the client calls more than 15 days before arrival, he/she will have the possibility to change the date of the reservation only once. If the client calls less than 15 days before arrival, the date cannot be changed.

The gift box date change insurance will only allow the modification of the reservation date, with up to 72 hours' notice on one occasion. In no case will it allow the refund of the amount of the gift box.

Only one insurance policy may be purchased per code. The gift code must be presented at check-in.

### 4. COMPLAINTS
